## Participant Agreement Assumption of Risk, Waiver of Liability, and Indemnification

This Participation Agreement must be signed and on-file with the CPL Youth Center as a condition for using the center's facility. Persons not registered with the CPL Youth Center are denied permission to use the center's facility.

Participants/Parents (if participant is 17 yrs of age or younger): Please read (or help your child read) and understand the following:

### I understand:

- that there are certain dangers, risks, and hazards inherent in the participation of youth center activities including but not limited to falling and/or colliding with fixed or movable structures and/or other participants;
- that the potential consequences of youth center activities include but are not limited to, the possibility of property damage, and/or bodily injury, including death, permanent disability, and other serious bodily injuries;
- that the rules and regulations to participate in the youth center as explained in any written materials and/or explained by youth center staff.
- The use of the youth center facility is conditioned on compliance with youth center rules and directions of the youth center staff; and

### I agree:

- that I participate in youth center activities at my own risk and that the CPL Youth Center and its Executive Officers, Board of Directors, employees, agents and representatives shall not be liable to me for any damage or injury, whatsoever, to my person or property arising out of or in connection with my use of, or presence in, the CPL Youth Center;
- to follow the directions of the CPL Youth Center's staff
- to inform a youth center staff member of any dangerous or potentially hazardous situation I may observe;
- that if I do not understand how an activity is performed or how a piece of equipment is to be used, I will ask a CPL Youth Center staff member prior to beginning the activity; and
- to abide by Youth Center Rules, a copy of which is attached hereto, as they may be amended, and such other rules as may be posted at the youth center.

In consideration of participant \_\_\_\_\_ receiving permission from the CPL Youth Center to use the center's facility, the undersigned participant (and his/her parent/guardian) hereby, knowingly and voluntarily agree, on behalf of themselves and their heirs, successors and assigns to:

- assume responsibility for all risks of loss, damage, or injury (including but not limited to disability and/or death) that may occur.
- Forever release and discharge the CPL Youth Center and its Executive Officers, Board of Directors, employees, agents and representatives from liability for any and all bodily injury (including but not limited to disability and/or death), property damage, and/or any other loss whatsoever which may arise out of, result from, or be associated with the participant's use of, or presence in, the youth center whether arising from the negligence of the Executive Officers, Board of Directors, employees, agents and representatives or otherwise; and
- Hold harmless and indemnify the CPL Youth Center and its Executive Officers, Board of Directors, employees, agents and representatives from liability for any and all claims, demands, or actions whatsoever for injuries, damages or losses to any person (including but not limited to disability and/or death) or property which may arise out of, result from, or be associated with participant's use of, or presence in, the youth center facility, whether said injury, damage, or loss is due to the negligence of the CPL Youth Center and its Executive Officers, Board of Directors, employees, agents and representatives, or otherwise.
